CHAPTER VII/10

ADMISSIONS IN THE SECOND - CYCLE OF STUDIES "PROFESSIONAL MASTER" AND "MASTER OF SCIENCE".

The candidate appears personally or through an authorized person on his behalf and submits the following documentation:

- a) Diploma and transcript/diploma supplement or a photocopy thereof certified by the original, of the completed first-cycle studies in the Republic of Albania. For diplomas from outside the country, accompanied by a photocopy of the diploma certified by the original, or, in its absence, another official document on the basis of which recognition and equivalence have been carried out in the Republic of Albania, issued in the country where the studies were completed, allowing registration and continuation of second-cycle studies; Candidates who have not completed the recognition and equivalence process of the diploma, submit a certificate that they have applied to the Center for Educational Services for recognition and equivalence;
 - b) Diploma of State Matura along with the transcript of grades or a photocopy thereof certified by the original, confirmed by the respective local education institution responsible for pre-university education (DRAP/ZVAP Regional Directory of Pre – University Education/ Local Office of Pre-University Education). Candidates who completed upper secondary school before the entry into force of Decision No. 876, dated 3.11.2010, of the Council of Ministers, "On some changes to Decision No. 78, dated 8.2.2006 of the Council of Ministers" On the establishment of the State Matura and admissions to public higher education institutions", as amended", submit the Maturity Certificate (original or a photocopy thereof certified by the original, confirmed by the respective local education institution responsible for pre-university education (RDPUE/LOPUE). If candidates do not possess a high school maturity certificate, they must submit a duplicate of the maturity certificate issued by the secondary school where they completed their education and confirmed by the respective local education institution responsible for pre-university education (DRAP/ZVAP, Regional Directory of Pre -University Education/ Local Office of Pre-University Education), or the document issued by the State Archive along with the transcript of grades;
 - c) Application form, according to the format of Appendix No.2, of this guideline;
 - d) Declaration according to Appendix No.1, an integral part and annexed to this guideline:
 - e) Photocopy of identification document (ID card, identification card, or passport);
 - f) Two personal photographs;

Additional documentation only for foreign nationals:





- Evidence of proficiency in the Albanian language, issued by the responsible structures, only for the foreigner who registers in a study program conducted in the Albanian language. The candidate who is of Albanian nationality and has knowledge of the Albanian language may submit any document from the country of origin proving proficiency in this language. This obligation is exempted for foreign nationals who have completed upper secondary education or a study program in the Albanian language at pre-university education institutions in the Republic of Albania.
- Candidates from special categories, in addition to the documents required above, submit:
 - Candidates with disabled status must also submit a photocopy authenticated by the original of the blind booklet issued by the State Social Service or a notarized copy of the decision of the (KMCAP) Medical Commission for Determining Work Capability.
 - Candidates with orphan status must also submit a photocopy authenticated by the original of the document certifying the orphan status issued by the State Social Service.
