#### TRANSFER AND SECOND PROGRAM

ADMISSION AND REGISTRATION PROCEDURES FOR CANDIDATES APPLYING FOR <u>TRANSFER</u> OF STUDIES AND FOR A SECOND <u>STUDY PROGRAM, IN FIRST CYCLE STUDY PROGRAMS</u>, IN PROFESSIONAL STUDY PROGRAMS, AND IN INTEGRATED SECOND CYCLE STUDY PROGRAMS, FULL-TIME, IN HIGHER EDUCATION INSTITUTIONS

All candidates wishing to apply for a transfer of studies must submit the following documents to the teaching secretariats covering the respective study program:

- a) Application form according to Annex no. 3;
- b) Declaration according to Annex no. 1;
- c) The complete study program plan, including relevant syllabi;
- d) Certificate of the list of grades and earned credits for each course and completed obligation, which will serve for the equivalence of subjects in the pursued study program; students transferring their studies from a foreign higher education institution must submit the complete study program plan, including relevant syllabi, and the list of grades and credits earned for each subject and obligation, translated into Albanian and certified as identical to the original;
- e) a certified copy (with the original) of the high school diploma (for candidates who completed high school in the Republic of Albania before 2011);
  - f) a photocopy of an identification document;
  - g) two personal photographs;
- h) a copy of the payment receipt.

At the time of final registration with documents at the higher education institution HEI (after being declared successful), the candidate must also submit the original deregistration document from the HEI they are transferring from, which must include:

- a) first name, father's name, surname;
- b) date of birth;
- c) place of birth;
- d) citizenship;
- e) enrollment number from the sending institution;
- f) name of the high school / higher education institution attended before enrolling in the current study program;
- g) state Matura ID / special registration number<sup>1</sup>;
- h) personal identification number;
- i) date of enrollment in the study program offered by the higher education institution (HEI);
- j) title of the study program and the corresponding faculty;

- k) cycle and form of studies;
- l) date of interruption of studies.

Candidates applying for a second study program (SECOND FACULTY) must submit the following documents to the academic secretariats responsible for the relevant study program:

- a) A request addressed to the HEI for the study program in which the candidate is applying for a second study program (or the application form according to Annex 6);
- b) A notarized copy of the university diploma of previously completed studies, accompanied by the diploma supplement;
- c) Certification of the list of grades and earned credits for each subject and completed obligation, which will serve for the equivalence of subjects and grades in the pursued study program (if recognition of passed exams and/or corresponding credits is requested);
- d) A notarized photocopy of the high school diploma (for candidates who completed high school in the Republic of Albania before 2011). In the absence of the State Matura diploma or high school diploma, a duplicate of the high school diploma issued by the high school administration and verified by the relevant Regional Directorate of Pre-University Education (DRAP/ZVAP), or a high school transcript issued by the State Archive, must be submitted;
- e) A photocopy of an identification document (ID card, identification booklet, or passport); f) Two personal photographs.

Candidates with a foreign diploma who are declared successful in these study programs are subject to the same application and registration procedures as all other candidates. Registration in these study programs can be carried out during the first semester and before the

first exam session. Registration as a student for successful candidates is provisional, pending the completion of the

recognition process for their academic documentation.
